**PLAINTIFFS' MOTION FOR
DISTRIBUTION OF CLASS SETTLEMENT FUNDS**

Plaintiffs Humberto Lozada and Oklahoma Firefighters Pension and Retirement System (together, "Plaintiffs"), by and through the undersigned counsel, hereby move the Court for entry of the [Proposed] Order, submitted herewith, which: (i) approves the distribution of the Net Settlement Fund pursuant to the Settlement of this Litigation, (ii) imposes a Final Bar Date of June 10, 2026, meaning that any claims received after the Final Bar Date, or purported cures of deficiencies received after the Final Bar Date, will be rejected without further notice, and (iii) approves payment to the Claims Administrator for its fees and expenses for its work.¹
